


The Adelie Land Treaty of Cession



The United Republics of Antarctica and the Federal Republic of New Potato Land, being desirous of strengthening the good faith, understanding and mutual goalward relations, which exist between them, have, for that purpose, agreed upon and signed the following articles:

ARTICLE I.

The President of the United Republics of Antarctica agrees to cede to the Federal Republic of New Potato Land, by this convention, immediately upon the exchange of the ratifications thereof, all the territory and dominion now possessed by the United Republics of Antarctica on *Adelie Land and Wilkes Land* on the continent of Antarctica.

As shown on the map below, the eastern limit is the line of demarcation at 120 degrees East of Greenwich, the western limit is the line of demarcation at 143 degrees East of Greenwich and the northern limit is the line of demarcation at 75 degrees latitude (from the South Pole):



ARTICLE II.

In the cession of territory and dominion made by the preceding article are included the right of URA national property and other edifices which are not private individual property or property belonging to other macronations around the world.

ARTICLE III.

The current inhabitants of the ceded territory, according to their choice, have a reserved right to automatic NLP citizenship as well as dual citizenship (URA/NPL) in the case of which they shall be admitted to the enjoyment of all the rights, advantages, and immunities of citizens of the United Republics of Antarctica, and shall be maintained and protected in the free enjoyment of their liberty, property, and religion. Any future inhabitants (with an exception of the relatives of current URA citizens) shall abide solely by the law and order of NPL unless otherwise allowed by the Government of NPL or voted via a referendum by citizens of the NPL.

ARTICLE IV.

Immediately after the exchange of the ratifications of this convention, any fortifications or military posts which may be in the ceded territory shall be delivered to NPL, and any URA troops which may be in the territory shall be withdrawn as soon as may be reasonably and conveniently practicable, with an exception of URA special units and formations pertaining to the Transantarctic Supramicronational Alliance.

ARTICLE V.

In consideration of the cession aforesaid, the Federal Republic of New Potato Land understands and agrees that the territories mentioned may be reclaimed partially or fully by the URA in the following cases explicitly:

1. Voluntary or involuntary dissolution of the NPL as a state or of its government.
2. NPL government overthrowal (or other methods of installation of a new government, state or diplomatic vector) leading to a policy which is actively hostile towards URA.
3. A voluntary gesture of the NPL resulting in an agreement between the NPL and URA.

ARTICLE VI.

Once this convention is ratified by the Executive Officer of the Federal Republic of New Potato Land on the one part, and on the other by the President of the United Republics of Antarctica, the ratifications shall be exchanged within one month from the date hereof or sooner if possible.

The said Treaty is ratified on both parts, and the respective ratifications of the same were exchanged by Vasia Bratchuk, President of the United Republics of Antarctica and the Josiah Welch, Executive Officer of the Federal Republic of the New Potato Land on the part of their respective governments, as proven by the signatures below.
